TIPSS-4 Ordering Procedures for IRS Program Managers — Small Business

- STEP 1: Follow IRS website instructions: Go to www.irs.gov; Use the search button to input "TIPSS-4 Ordering Procedures" or Contact TIPSS team: Phone (202) 283-1110 or E-Mail tipss@irs.gov. An IRS facilitator will work with requestors.
- STEP 2: Develop the Task Order Request Package (TORP).
- **STEP 3:** Customer returns TORP to the CO. The CO reviews and discusses documentation with the customer. Once the CO verifies the TORP is ready for processing, they will start the task order award process.
- STEP 4: (Fair Opportunity Exception Ordering:) The CO, along with the requiring activity, determines the application of the Fair Opportunity Exception. This process allows a HUBZone set-aside procurement for tasks up to \$3.5 million. VariQ is a HUBZone company and qualifies under this simplified process. (If the Fair Opportunity Exception does not apply, skip to Step 5.) Issue award.
- STEP 5: (Standard Ordering:) The CO prepares RTCP or RTPP solicitations for the list of competing TIPSS-4 SB contractors.

TIPSS-4 SB CS — \$3.5 MILLION THRESHOLD SET-ASIDE FOR HUBZONE FIRMS

Excerpts from Contract Section H. 30: In accordance with FAR Subparts 19.13 HUBZone, the TIPSS-4 Small Business Cybersecurity task area may use these programs as set-asides for task order requirements. In addition, please see Section G.4.1. All task orders valued at \$3.5 million or less under the Cybersecurity Principal Task Area may be set-aside for HUBZone and SDVOSB (Section G.4.1. Fair Opportunity Process).
